**Description:** American Honda Motor Co., Inc. (Honda) is recalling certain 2018-2020 model year Accord 1.5T vehicles. The fuel pump impeller was improperly moulded, resulting in low density impellers. Over time, the low-density impeller can deform and interfere with the fuel pump body, rendering the fuel pump inoperative.

If the fuel pump module is inoperative, the engine may not start or can stall while driving, increasing the risk of a crash or injury.

**Remedy:** Registered owners of all affected vehicles will be contacted by mail and asked to take their vehicle to an authorized Honda dealer. The dealer will replace the fuel pump module with an improved part. Owners who have paid to have these repairs completed at their own expense may be eligible for reimbursement, in accord with the recall reimbursement plan on file with NHTSA.
